This paper highlights the importance of biographies among Muslims in the context of the introduction of these biographers' practices and compilations and gives the best motivation to follow the biographies of religious leaders, especially the Holy Prophet (PBUH).

The 3rd paper of this issue is related to the Islamic system and rules of child upbringing. In fact, from the Islamic point of view, the upbringing of a child starts from the moment of his birth. Therefore, it is the duty of parents in Islam to pave the

The theme of the 4th paper is "Religious Foundations of Dialogue in the Context of Buddhist Influences in Gilgit". According to the author, although there are no Buddhists in Gilgit-Baltistan, there are traces of Buddhism in the area.
